Approximately 660 undergraduates received degrees at the 95th commencement exercises of the Massachusetts Institute of Technology, on Friday, June 9. Dr. Frank Stanton, president of the Columbia Broadcasting System, was the speaker. Dr. James R. Killian, Jr., Chairman of the M. I. T. Corporation, presided, and Dr. Julius A. Stratton, President of M. I. T., delivered the charge to graduating students.

Commencement was the climax of the traditional Senior Week, which included such events as the class banquet, the baccalaureate service, and military commissioning exercises. Following the commencement program a luncheon and reception were held on the lawn of the Great Court for the graduates and their parents.
